(Dawniej OK System Polska S.A.) with its registered office in Warsaw (00-807), Aleje Jerozolimskie 96, and also the website administrator - Facebook - as the entity jointly responsible for the processing of the data of people using the Medicover SPORT fanpage or the Messenger communicator. ### **3 Purpose and legal grounds for personal data processing**

Your data will be processed for the following purposes:

- administration and management of the fanpage under the name **Medicover SPORT**, replying to posts and comments published by you as well as supervision of the content published by users - the legal basis for the processing is the legitimate interests of Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) which consists of the possibility of running and managing the Medicover SPORT's fanpage;
- replying to inquiries directed to Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) through the Messenger communicator - the legal basis of the data processing is the legitimate interest of Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) which consists of the possibility of providing an answer to people who contact Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.);
- pursuit of other legitimate interests of Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.), which, according to Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.), include but are not limited to the possibility of asserting and defending claims, preventing fraud and economic offences, and ensuring the security of the IT environment. Furthermore we would like to inform you that the administrator of Facebook, as the provider of tools related to the fanpage and the Messenger communicator, is an entity which is jointly responsible for the processing of the data of the people who use the fanpage and the Messenger communicator, which may process their data for its own purposes, based on different legal grounds. In particular, Facebook, based on its own decisions and regulations may collect and process information included in the cookies of people who visit the fanpage. Based on the data collected in this way, anonymous compilations of materials and statistics may be created by Facebook (e.g. regarding the number or profile of fanpage visitors), which may be made available to Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) as the entity running the fanpage.

### **4 Data recipients**

Your personal data published on Facebook in connection with using the Medicover SPORT fanpage, or provided through the Messenger communicator, may be available to the administrator of this portal, i.e. Facebook. At the same time all personal data included in comments published on the Medicover SPORT fanpage may also be available to other users of the Facebook portal. We will also transfer your personal data to our suppliers to whom we outsource the provision of services related to personal data processing, e.g.:

- IT service providers

Such entities process data based on a agreement with us and only in accordance with our instructions.

## **5 Data storage period**

Your personal data will be processed by Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) for the period necessary to accomplish the aforementioned processing purposes, in particular, for the period during which you are an active user of the fanpage, or until an objection is reported by you regarding the processing of your personal data.

The data included in your posts or comments may be processed until they are deleted. If you are not able to delete a comment you can address such a request to us. You can always resign from "viewing" or "liking" the Medicover SPORT fanpage, you can also report your objection as to the processing of your personal data for these purposes. Irrespective of the storage of data by Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) the Facebook administrator may apply its own data storage periods.

## **6 Rights of data subjects**

You have the right of access to your data and the right to demand their rectification, erasure or restriction of their processing. Insofar as the basis for the processing of your personal data is a pre-requisite of the legitimate interests of Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.), you have the right to object to the processing of your personal data. You also have the right to lodge a complaint with the supervisory authority which deals with personal data protection. In order to exercise the aforementioned rights, contact the data controller. The contact details are provided above. Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) may exercise your rights to such an extent as to which it has the technical capacities to do so (e.g. By deleting, at your request, a comment or post which contains your personal data). Regardless of any contact with Medicover Sport Sp. z o.o. (Dawniej OK System Polska S.A.) on the processing of your data via Facebook or the Messenger communicator, you can also contact the administrator of Facebook.

## **7 Information on the requirement to provide data**

The provision of personal data when using the fanpage is voluntary. Failure to provide data may make the use of certain functionalities (such as the ability to post comments or contact us by means of the Messenger communicator) impossible.
